This pivotal role offers the opportunity to shape the inclusive culture of our school and ensure every pupil thrives both academically and emotionally.

Key Responsibilities:

- Lead the SEND provision as the designated SENDCo, ensuring compliance with statutory requirements and delivering personalised support to pupils with additional needs.
- Act as the Designated Safeguarding Lead (DSL), championing child protection and safeguarding across the school.
- Lead and develop the pastoral team to provide outstanding emotional and social support for pupils.
- Collaborate strategically with senior leaders, staff, parents, and external agencies to promote inclusion and well-being.



- Oversee and monitor the progress and welfare of vulnerable pupils, ensuring timely interventions.
- Support and line-manage the Deputy SENDCo who leads a class of high needs pupils.

- Qualified SENDCo status or working towards it.
- Proven expertise in safeguarding with the ability to fulfil the role of Designated Safeguarding Lead.
- Demonstrable leadership experience in SEND provision and pastoral care.
- Strong understanding of SEND legislation, safeguarding policies, and best practices.
- Experience working with vulnerable children in a primary school setting.
